NATURE OF WORK: The candidate will be required to do research work in experiments/theory/modeling, assisting characterization studies, system modifications, routine lab maintenance, and other project-related work.

AGE LIMIT: Not more than 28 years on 01/04/2022. Age relaxation is admissible to SC/ST/OBC/Differently-abled etc. as per Govt. of India notifications. The age limit is relaxable by five years for SC/ST, three years for OBC, and ten years for Differently-abled person.

TENURE: Junior Research Fellow (JRF) will be appointed initially for a period of two years and will be extended/promoted to SRF subject to satisfactory performance.

REMUNERATION: ₹31,000/-p.m. + HRA (Consolidated) which will be raised to 35,000/- + HRA per month after two years, subject to satisfactory academic performance. Support to attend national conference/workshops/schools and partial support for attending conference abroad will be given during their Ph.D. Tenure.

SELECTION PROCESS: The candidates who satisfy the above criteria may apply for the positions by filling the application form given in this advertisement. The short-listed candidates will be invited to appear for a national-level written test that will be conducted at CPP-IPR. No TA/DA will be admissible to any candidates for attending the written test. The single paper (multiple choice questions based) written test, conducted only for screening, will be held likely in August/September, 2022. Candidates qualifying in the written test will be called for personal interview at CPP-IPR. NET, JEST and GATE qualified students can directly appear for the interview at CPP-IPR. Final selection will be based only on the personal interview. Based upon the number of candidates who qualify in the written test and those qualified in NET, JEST and GATE examinations, the interview may be held on the same day of the written test or later as notified. Candidates selected for personal interview will be paid to and fro sleeper class railway/bus fares via the shortest route on production of valid tickets.

The prescribed Essential Qualifications are the minimum and mere possession of the same does not entitle candidates to be called for interview. In the event of number of applications being large, the Institute will adopt short-listing criteria to restrict the number of candidates to be called for written test/interview to a reasonable number by one or more of the following methods in the given sequence.

- Percentage of marks obtained in the M.Sc. examination.
- CSIR-UGCNET/GATE score.
