**Important Note: -**

1. Candidates who opted for an offline interview mode must bring the following documents (documents submitted through the application form) for verification. After the document verification only, the eligible candidates as per the required criteria will be allowed to appear for the interview.
  - a. Original certificates of all Educational Qualification Certificates/Mark sheets (from Class 10th standard onwards) which have been submitted by the candidate with the application form.
  - b. Original Certificates in support of Age, Caste, PwBD, working experience, if any, and all other documents that have been submitted by the candidate with the application form.

- c. Original Photo Identity proof along with 01 copy of photocopy of the same.
  - d. No objection certificate from employer, if employed.
2. The candidates are allowed to appear personal interview through **online mode**; subjected to the condition that ***if the candidate gets selected for the said post, will have to produce all requisite documents as mentioned in the serial no. 01 above i.e. uploaded testimonial/documents/ certificates (in support of age, education qualifications (starting from 10th onward), caste, PwBD, working experience etc.) in original for verification prior to the joining. In case of inability to produce these requisite documents in original prior to the joining, his/ her candidature will stand automatically cancelled, and no further his/ her request will be entertained.*** Please ensure that you fulfill all the requisite/eligibility criteria completely as given in the advertisement. If it is found, even in the later stage also that **any** of the requisites/eligibility criteria as given in the advertisement is not fulfilled by you, then your candidature/selection (if selected) will summarily be canceled. You are requested to prepare for the online interview with a smartphone/laptop computer/desktop computer with a web camera, speakers and microphone, etc., and good internet connectivity. There should be no background noises and candidates should sit alone during the interview. CPP-IPR is not responsible for any internet connectivity issue from the candidate's side and no request for a re-interview will be entertained. Candidates must be ready 15 minutes before the scheduled time of the interview. The time of the interview along with the online link will be sent to the candidates' e-mail ID in due course of time. While joining the interview link, the candidate will ensure that the full name of the candidate should be displayed on the window with the video/web camera 'ON' during the interview. Please remain reachable by phone throughout the period from 09:00 AM – 05:00 PM on the respective interview dates.
  3. Please note that **no separate call letters for appearing in the Personal interview with the shortlisted candidates will be sent by post.**
  4. All candidates must ensure that the name provided in the application form as well as in the submitted testimonial/documents/ certificates should be the same as photo identity proof and depicted in nature.
  5. Candidates will be paid to and fro sleeper class railway/bus fares via the shortest route on production of valid tickets as per the CPP-IPR rule. No accommodation will be provided to the candidates; candidates have to arrange the same for themselves.
  6. Candidates have to follow and maintain COVID-appropriate protocol at all times.
  7. Candidates are advised to be careful in the preceding days of the Personal Interview and refrain from coming with the contact of COVID positive persons.
