1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

12. **Buyer Added Bid Specific ATC**

- A)** The supplier must provide the instruction/user manual. The vendor should have a service centre/facility with complete infrastructure within India to carry out all necessary repairs of the Turbo Pump (such as replacement of the stator/rotor assembly and repair of electronics), along with the availability of critical spare parts.
- B)** The installation of the entire system must be carried out by an authorized representative of the manufacturer. The representative is required to bring a pressure monitoring system for vacuum testing at CPP-IPR.
- C)** Bidders must submit a duly filled and signed Self-Certification under the "Preference to MAKE IN INDIA" Order (Annexure-I). Failure to do so will result in disqualification from further evaluation.
- D) Packing & Delivery Note:** In case of an order, all packages must be clearly superscribed with details such as the GeM Contract No., Consignee Name, Phone Number, etc., to prevent the consignment from being refused at the time of delivery.
- E)** Bidders must upload a duly filled-in compliance statement with accurate facts and figures. Any deviation or mismatch in the specifications mentioned in the technical compliance sheet will not be accepted.
- F) Note - Performance Security Bank Guarantee:** The supplier must ensure delivery of the original hard copy of the BG/DD to the buyer within 15 days of the contract award. The BG/DD should be valid for a period of 18 months.

G) Acceptance criteria:

1. The items should reach the CPP-IPR site in a damage-free condition.

2. The item should be supplied as per the quoted specification.
3. The manufacturer or authorised supplier has to demonstrate the supplied items at CPP-IPR. For TM P, the required achievable pressure is of the order of 10^{-6} mbar or better at the time of installation.
4. The pump will be tested for continuous and smooth running for two hours at the maximum r.p.m. of the turbo-pump without error after the installation.
5. Acceptance of the item is subject to successful installation, demonstration, and testing.

H) NOTE:

- I. Submission of the offer shall be deemed acceptance of all terms and conditions mentioned in the bid documents, including delivery period, payment, ePBG, etc. Any deviation found in uploaded documents shall not be considered. The GeM GTC, STC, and all the clauses incorporated by the Buyer in ATC and various corrigendum of the bid will be final.
- II. **RECTIFICATION AND REPLACEMENT OF DEFECTIVE STORES:** In case repair/replacement of defective/rejected stores during the warranty period is necessary and becomes essential to return the stores, to the contractor, where the purchaser has already made full or part payment, the contractor shall submit bank guarantee for the value of stores so found defective/rejected as per **Annexure-III** valid till receipt and acceptance of repaired/replaced/entire stores within fifteen days of intimation to collect the stores. However, the contractor will not be absolved from his responsibility as specified in the bid document.

14. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.
