1. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating

Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

7. Buyer Added Bid Specific ATC

- A)** Bidders are required to submit a duly filled and signed Self-Certification under the **“Preference to Make in India” Order (Annexure-I) and an undertaking (Annexure-II for availing MSE purchase preference)**, strictly in the prescribed format, without making any modifications to the documents uploaded under the “Buyer Uploaded ATC Document.” Failure to comply with this requirement will result in the offer being rejected from further evaluation.
- B) PACKING DELIVERY NOTE:** In case of an order, all the packages invariably will have details (superimposed) like Gem Contract no., consignee name, Phone No, etc., to avoid refusal of the consignment at the time of delivery.
- C)** Bidder must upload duly filled-up facts and figures in the prescribed compliance statement with actual values. Any deviation/mismatch of the specifications mentioned in the technical compliance sheet shall not be accepted.
- D) Offer Validity-** Required offer validity for this bid is 120 days from the date of Opening of the bid, and the same will be extended accordingly (if required).
- E) Note - Performance Security Bank Guarantee:** - Supplier has to ensure delivery of the hard copy of the original BG/DD to the Buyer within 15 days of award of contract with a validity period of 18 months.

F) Eligibility Criteria:

The manufacturer should have experience in fabricating high voltage carbon ceramic disc resistor assembly for last 10 (ten) years which should be supported by its description in their website. As proof of experience, the vendor has to provide five (5) previous purchase orders (P.O) for five different years against similar type of resistor assembly manufactured by the same OEM.

G) Acceptance Criteria:

1. The item should reach CPP-IPR in a damage-free condition. So, the items should be packed properly.
2. The item has to be provided as per the quoted specifications.
3. Vendor has to provide technical specification conformity certificate from the original manufacturer.

H) NOTE:

- I. Submission of the offer shall be deemed acceptance of all terms and conditions mentioned in the bid documents, including delivery period, payment, ePBG, etc. Any deviation found in uploaded documents shall not be considered. The GeM GTC, STC, and all the clauses incorporated by the Buyer in ATC and various corrigendum of the bid will be final.
- II. **RECTIFICATION AND REPLACEMENT OF DEFECTIVE STORES:** In case repair/replacement of defective/rejected stores during the warranty period is necessary and becomes essential to return the stores, to the contractor, where the purchaser has already made full or part payment, the contractor shall submit bank guarantee for the value of stores so found defective/rejected as per **Annexure-III** valid till receipt and acceptance of repaired/replaced/entire stores within fifteen days of intimation to collect the stores. Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. 13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
