Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service

provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. F) **Eligibility Criteria:** The manufacturer should have experience in fabricating high voltage carbon ceramic disc resistor assembly for last 5 (five) years which should be supported by its description in their website. As proof of experience, the vendor has to provide two (2) previous purchase orders (P.O) for two different years against similar type of resistor assembly manufactured by the same OEM.

G) **Terms and conditions:**

- (i) The item shall be custom-designed and manufactured in accordance with the specifications provided in the enquiry document. The bidder shall submit a tentative design proposal, including detailed drawings and relevant technical specifications, along with the quotation. The submitted design documents shall form the basis for the technical evaluation of the proposed custom-built assembly. Failure to submit the required design proposal and drawings may result in the quotation being considered technically non-responsive.
- (ii) The bidder shall submit a **Technical Specification Conformity Certificate** or a **Factory Test Report** issued by the original manufacturer, demonstrating compliance with the technical specifications stipulated in the enquiry document.
- (iii) The representational drawing of the resistor stack is provided solely for the purpose of illustrating the general configuration and structure of the assembly. The selection of resistor discs, as well as the detailed design, structure of the resistor stack, shall be the responsibility of the manufacturer, provided that the completed assembly fully complies with the technical specifications and performance requirements stipulated by CPP-IPR.
- (iv) The vendor shall submit the complete design package, including detailed engineering drawings, design calculations, and technical analysis, demonstrating compliance with all specified technical requirements, to CPP-IPR for review and approval. Manufacturing of the ordered item shall commence only after obtaining written approval of the design package from CPP-IPR.
- (v) The vendor has to provide authorisation letter from the original manufacturer.

H) **Acceptance Criteria:**

- (i) The item shall be suitably packed to ensure safe transportation and delivery to CPP-IPR in a damage-free condition. The vendor shall be responsible for providing adequate packing and protection to prevent any damage during handling, transit, and unloading.
- (ii) The supplied item(s) shall fully comply with the technical specifications stipulated in the enquiry document. Final acceptance by CPP-IPR shall be subject to verification of full compliance with all specified technical and performance requirements. I) **NOTE:**

The seller should guarantee the rectification of goods in case of any break down during the guarantee period.
