OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

## 2. **Generic**

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

## 3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

## 7. **Payment**

**PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

## 8. **Buyer Added Bid Specific Scope Of Work(SOW)**

Text Clause(s)

### SCOPE OF WORK:

The service provider is required to provide a 7-seater passenger vehicle, complete with a driver and fuel, for the staff, guests, and other official purposes of CPP-IPR, Sonapur, Kamrup, Assam.

Service Details:

- Ø The service includes pick-up and drop-off from the designated point to CPP-IPR and return, as well as other official duties during office working hours on working days (Monday to Friday), as well as on Saturday, Sunday, and holidays as per the need raised by the concerned authority of CPP-IPR.
- Ø The vehicle usage per month is expected to be 1300 Kms & 260 hours in the Local category

- Ø The office working hours are from 09:00 AM to 05:30 PM.
- Ø Pick-up and drop-off points will be a place within Kamrup (M).
- Ø The tentative route is Bhetapara - Beltola - Survey - Khanapara - CPP-IPR. While returning from CPP-IPR, the route will be in reverse order.
- Ø The reporting point of the vehicle will be near Bhetapara around 08:10 am.

Service Provider Responsibilities:

- Ø The service provider shall appoint experienced and skilled drivers who possess valid commercial licenses as required by the transport department.
- Ø Obtaining the necessary permission/approval of the concerned State police/appropriate authorities shall be the responsibility of the service provider.
- Ø The service provider shall not be eligible for any empty kilometers. However, the route and timing may vary as per CPP-IPR requirements.

Vehicle Requirements:

- Ø The contractor shall ensure that the vehicle provided is in good condition, roadworthy with proper/comfortable seats to withstand the strain of a long journey.
- Ø The models of the vehicle should be of the year 2021 (January or later) based on the date of manufacturing with a minimum of 1200 cc engine displacement.

The vehicle should be registered for operating as passenger vehicles (With Commercial Registration) and should not have travelled for more than 75,000 kilometers on the date of award of contract.

**9. Buyer Added Bid Specific ATC**

The bidder has to submit documentary proof as per the pre-qualification criteria as mentioned below. Exemption to these pre-qualification criteria is as per Gol rules and guidelines.

(a) The bidder has to be a company/proprietor/partnership firm registered for this purpose under any Law/ Act of Govt. of India. Supporting documentary evidence (Certificate of incorporation/ Registration, etc. ) must be enclosed.

(b) The bidder shall have an office/ Branch office/ Customer relationship Office in Sonapur/ Kamrup(M)/ in a place within a 50 km road distance from CPP-IPR. A valid documentary proof shall be enclosed along with the bid.

(c) The bidder shall have a GSTIN Reg. no., PAN/ TAN Registration Certificate. Documentary proof in this regard must be submitted.

(d) The bidder shall have a valid permit, license, and insurance required to perform the service. Documentary proof must be submitted while carrying out the contract.

(e) The bidder must submit duly filled, sealed and signed all the annexures given in the ATC in the prescribed format. Non-submission of the annexures in the prescribed format will be liable for rejection of the bid.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
